As per Government Gazette No 48104 dated 24 February 2023, further information is required in terms of section 18A(2)(vii) for purposes of a receipt issued under section 18A(2)(a) of the Income Tax Act, 1962 (ACT NO.58 of 1962)

The notice came into effect on 1 March 2023 and applies to S18A receipts issued on or after this date. In addition to the information previously required the following additional information would need to appear on all S18A receipts:

- Donor nature (natural person, company, trust, etc.)
- Donor Identification type and country of issue (in case of a natural person)
- Identification number of individual and/or registration number of Company
- Tax reference number of the donor
- Contact number of the donor
- Electronic mail address of the donor
- Trading name of the donor (if different from the registered name)
